SPACIO VIP TERMS:

Your membership term would begin today for an initial membership period of 3 months.

Membership dues are \$79 per month, with the first payment due today. Your credit card will then be charged each month thereafter for this amount until your membership expires or is terminated in accordance with the terms of this agreement.

After this initial 3 month term, your membership will be automatically renewed on a monthly basis and charged to your credit card. Your membership will continue on a month-to-month basis until your membership is canceled.

You can cancel at any time after the first three months with no penalty. All cancellations require a 30-day written notice. Upon cancellation, any unredeemed services will expire. You are responsible for any and all fees incurred until the cancellation is effective, according to the terms of this agreement.

VIP CLUB RULES AND GUIDELINES:

- 1.) Not valid with any other offers.
- 2.) Membership fees may not be paid with gift cards.
- 3.) Permission must be granted in writing for any transfer of membership treatment.
- 4.) You may cancel a massage or facial treatment more than 24 hours in advance of the appointment with no penalty.
- 5.) Less than 24 hours notice of cancellation will result in a charge of 50% of the scheduled service price. If you do not call to cancel or do not show up for your scheduled appointment, you will be charged full price for the scheduled service.
- 6.) Your membership status must be active in order to redeem any membership services including membership massages or facials. Picture ID may be required to establish membership enrollment.
- 7.) All membership cancellations require 30 days written notice and are effective 30 days after the date received. Payments due prior to the effective date will be charged as scheduled.
- 8.) Rewards Club discounts apply to all products and services but not the VIP membership fee.
- 9.) Massage or facial credits may be applied to other services or products.
- 10.) A fee of \$79.00 will be charged for any membership that is canceled in the first three months.
